This is a contract between Goose Creek Bed & Biscuit (herein after called the "Kennel") and the pet owner whose signature appears below (herein after called the "Owner").

1. Owner agrees to pay the rate for boarding agreed to when the pet is checked into the Kennel.
2. Owner further agrees to pay all costs and charges for special requested, and all veterinary costs for the pet during the time said pet is in the care of the Kennel. Charges are incurred by 1:00pm each day.
3. Owner further agrees that the pet shall not leave the Kennel until owner pays for all charges to the Kennel.
4. By signing this contract and leaving the pet with the Kennel, the owner certifies to the accuracy of all information given about said pet on the boarding forms.
5. Kennel shall exercise reasonable care for the pet delivered by the owner to the Kennel for boarding. It's expressly agreed by the owner and the Kennel that the Kennel assumes no liability for loss or damage from disease, death, running away, theft, fire, injury to other persons, other dogs or property or other unavoidable causes by said pet, due diligence and care having been exercised by our staff.
6. Owner specifically represents that he/she is the sole owner of the pet, free and clear of all liens and encumbrances.
7. Owner specifically agrees that said pet has not been exposed to rabies, distemper or Kennel Cough within a 30 day period prior to boarding.
8. Owner specifically agrees that said pet has not bitten any persons or animals within a 30 day period prior to boarding.
9. Owner agrees to pay the veterinary charges as agreed on the Medical Release Form.
10. During any 4 night or longer and any holiday stays; a deposit of \$50 will be required to reserve your spot. If canceled 48 hours prior to the drop off date the deposit will be refunded.
11. Owner agrees that if the pet is not called on within 10 days after the scheduled departure date, the pet will be considered abandoned and become the property of the Animal Medical Clinic of Goose Creek, Inc. and may be sold or disposed of at will. Notice of such intended sale or disposal will be mailed to the address given herein, not less than 15 days prior to the date of intended sale or disposal, and no further notice shall be deemed necessary.
12. Provable and/or Royal Canin Low Fat GI wet food may be added to your account to treat diarrhea while your pet is boarding or in some cases to encourage your pet to eat.
13. All terms of the contract shall be binding.
14. Owner agrees to pay a non-cancellation fee if reservations are not cancelled with 48 hours notice.
